#### **RESOLUTION ON**

## THE ROLE OF PARLIAMENT IN PROMOTING ASEAN DIGITAL TECHNOLOGICAL INTEGRATION, TOWARDS THE MASTER PLAN ON ASEAN CONNECTIVITY 2025 AND BEYOND

#### Sponsored by the Lao PDR

#### The Forty-fifth AIPA General Assembly:

**Recalling** the Master Plan on ASEAN Connectivity adopted by ASEAN Leaders in Hanoi, Viet Nam, on 28 October 2010 and Vientiane Declaration on the Adoption of the Master Plan on ASEAN Connectivity (MPAC 2025) adopted in Vientiane, Lao People's Democratic Republic, on 6 September 2016;

**Recognising** AIPA Resolution Res.40GA/2019/Eco/03 on Improving Digital Connectivity to Support the Growth of MSMEs, adopted at the 40th AIPA General Assembly in Bangkok, Thailand, in 2019, which highlights the importance of digital connectivity as a contributing factor to the development of MSMEs;

**Recalling** AIPA Resolution Res.42GA/2021/Eco/01 on Promoting Inclusive Digital ASEAN to Empower MSMEs and Strengthen the ASEAN Economic Integration, adopted in Brunei Darussalam in 2021, which called for the acceleration and harmonisation of digital integration across ASEAN; and for more affordable and accessible digital infrastructure and regional consensus on data governance to support the increasing demand for digital connectivity in the region;

**Recalling** <u>AIPA Resolution Res.44GA/2023/Eco/04</u> on Promoting Innovation, Transfer, Application and Development of Science and Technology for Sustainable Growth and Development, adopted in Indonesia in 2023, which promotes the transfer of scientific developments and technologies, innovation among ASEAN Member States and from more advanced industrialised countries to the ASEAN region;

**Recalling** AIPA Resolution Res.44GA/2023/WAIPA/03 on Digital Transformation Led by Women and for Women, adopted in Indonesia in 2023, which promotes women and girls' participation in digital transformation and encourages ASEAN women parliamentarians to actively assist in the development of relevant legal frameworks to accelerate the digital transformation process in ASEAN Member States;

**Recalling further** AIPA Resolution Res.44GA/2023/YPA/01 on Advancing Youth Engagement for Inclusive Development, Economic Transformation, and Democratic

Participation adopted in Indonesia in 2023, which calls upon AIPA Member Parliaments to enact and ensure the effective implementation of legislation that supports and promotes youth entrepreneurship in the digital economy, especially in providing a conducive environment for innovation and growth;

**Acknowledging** the progress made towards the MPAC 2025, which aims to achieve a seamlessly and comprehensively connected and integrated ASEAN that will promote competitiveness, inclusiveness, and a greater sense of community and the ongoing development of the ASEAN Connectivity Strategic Plan (ACSP) as part of the ASEAN Community Vision 2045, which aims to build on the achievements and lessons learned from MPAC 2025, ensuring continued progress in regional integration and connectivity;

**Recalling** the <u>ASEAN Economic Community Blueprint 2025</u>, which aims to create a deeply integrated and highly cohesive ASEAN economy, and the <u>ASEAN Digital Masterplan 2025</u>, which envisions ASEAN as a leading digital community and economic bloc;

**Recognising** the importance of digital technology in driving economic growth, innovation, and competitiveness within the ASEAN region, and the significant progress made by ASEAN Member States in expanding digital infrastructure and promoting digital literacy and skills;

**Noting** the challenges that remain in achieving equitable digital access across the region, the lack of digital literacy among end-users, infrastructure investment, and a harmonised approach across ASEAN are key barriers to achieving the goal of <u>ASEAN Digital Masterplan 2025</u> and beyond;

**Acknowledging** the efforts to negotiate and support the timely conclusion of the ASEAN Digital Economy Framework (DEFA), which aims to be the most comprehensive and leading digital economy agreement in the region;

**Emphasising** the role of parliamentarians in creating an enabling environment for digital technological integration through their legislative, oversight, and representation functions;

**Reiterating** the crucial roles of Parliaments to promote the harmonisation of policies and legislation that support ASEAN economic digital integration, which prioritises connectivity, regional integration, and narrowing the development gaps among ASEAN Member States, especially in sub-regions and remote areas;

**Acknowledging** the ongoing efforts to negotiate and support the conclusion of the ASEAN Digital Economy Framework Agreement (DEFA) as the region's most comprehensive digital economy agreement while emphasising its importance in advancing a modern strategy for an ASEAN Digital Economy that enables seamless and secure flows of goods, services, and data, underpinned by strong regulations, infrastructure, and skilled talent.

#### Hereby resolves to:

**Call upon** AIPA Member Parliaments to prioritise the enactment of legislation that supports the goals of the MPAC 2025 and beyond, ASEAN Digital Economy Framework Agreement (DEFA) and beyond, particularly in the areas of digital literacy, digital infrastructure and cybersecurity;

**Encourage** AIPA Member Parliaments to advocate for policies that incentivise investment in and the protection of digital infrastructure, such as broadband connectivity, leverage technology to improve connectivity and access, particularly in underserved areas:

**Call for** AIPA Member Parliaments to promote initiatives aimed at improving digital connectivity across ASEAN, ensuring that all Member States have access to reliable and affordable internet services;

**Encourage** AIPA Member Parliaments and ASEAN Member States to strengthen capacity-building initiatives for parliaments, government officials, businesses, and the general public to enhance digital literacy and skills, ensuring widespread digital inclusion, foster knowledge-sharing platforms and exchange of best practices to help accelerate digital transformation and address challenges;

**Urge** AIPA Member Parliaments to foster ASEAN Member States to promote digital integration initiatives and robust cybersecurity frameworks; adopt comprehensive data protection laws that safeguard citizens across the region; and emphasise inclusive digital technological integration that bridges the digital divide and leaves no one behind;

**Encourage** AIPA Member Parliaments to promote gender equality, women's empowerment and youth engagement in the digital sector and innovation through STEM education, digital skills training, support for start-up ecosystems, youth-led digital initiatives, women-led and women-for initiative digital entrepreneurship, and leadership roles in the tech industry;

**Urge** AIPA Member Parliaments to encourage ASEAN Member States to collaborate among private sectors, Development Partners and the ASEAN Infrastructure Fund for providing capacity building, technical and financial assistance to implement the digital integration initiatives;

**Recommend** AIPA Member Parliaments to strengthen their oversight roles in the implementation of laws and regulations by identifying unnecessary regulatory barriers that hinder initiatives towards digital integration and evaluating these initiatives to ensure digital integration achievement and alignment with the goals of the <a href="MPAC 2025">MPAC 2025</a> and beyond.
